What is the purpose of this form?

Firstly this form is required to prove that you have voluntarily entered a relationship with the Laferla Group which includes:

The aim of this form is to allow us to manage your relationship with the Laferla Group and keep you informed regarding services offered by the Group.

Also, as part of our obligations under data protection regulation, in particular the EU General Data Protection Regulation (GDPR), we are required to ensure that your personal data is kept up-to-date.

What information do you need?
